**5. DECLARATION OF CANTONMENT AS ODF AREA : HIRING OF MOBILE TOILETS :**

Reference Circular agenda dated 06.09.2017 as noted vide CBR No. 01 dated 18.09.2017 for hiring of mobile toilet 10 seaters 05 Nos on monthly rent basis and office report on subject matter.

To note the action taken of hiring of 10 seaters mobile toilets 05 nos. for further period of 02 months w.e.f.01.01.2018 from the same firm and rate, terms and conditions as approved by the Board vide CBR under reference, as the process of purchasing of Mobile toilets is in progress and it will take time upto march 2018 for fabrications of the same as these 05 mobile toilets are required to maintain the Cantonment as ODF Area. The approximate expenditure will come to Rs.2,95,000/- per month for 05 Nos. mobile toilets (10 seaters). The expenditure is to be met out of relevant head of the Budget Estimates for the current financial year.
