1. CLOSURE OF MALL ROAD IN FRONT OF HQ 2 CORPS:

Reference CBR No. 7 dated 12.07.2019.

Meeting of the committee constituted vide CBR referred to above for the hearing of claims, objections & suggestions in respect of closure of Mall Road in front of HQ 2 Corps was held on 02.08.2019 at 1000 hrs in the office of Cantonment Board, Ambala. The committee went through the 257 claims, objections & suggestions received in this regard.

A public notice bearing No. ACB/AE /2019/1330 dated 30.07.2019 was published in the newspapers The Tribune, Dainik Bhaskar & Amar Ujala regarding hearing of claims, objections & suggestions for closure of Mall road in front of HQ 2 Corps on 05.08.2019 from 1000 hrs to 1200 hrs in the office of Cantonment Board Ambala, but no one was present on the above said date and time. Further, a public notice for final hearing on 08.08.2019 from 1000 hrs to 1200 hrs in the office of Cantonment Board, Ambala was again published vide letter No. ACB/AE /2019/1381 dated 05.08.2019 in the newspapers The Tribune, Dainik Bhaskar & Amar Ujala.

On 08.08.2019, final hearing of claims, objections & suggestions for closure of Mall road in front of HQ 2 Corps was conducted in the office of Cantonment Board Ambala from 1000 hrs to 1200 hrs. 89 persons from the area of RHA Bazar, RHA Parade, Defence Colony, village Garnala, Janetpur, Panjokhra, Tundli etc. were present.

Opportunity was given by the committee to every person to speak regarding Closure of Mall Road in front of HQ 2 Corps. Out of present 89 persons, 21 persons spoke against the closure of said portion of Mall Road.

The Committee report dt. 08.08.2019; public claims, objections and suggestions alongwith relevant files is put up for consideration and decision.

RESOLUTION : Sh. Ajay kumar Baweja, Vice President Cantonment Board and Smt Ashima, MCB put across arguments against the closure of Mall road. However PCB and nominated members re-emphasized that as HQ 2 Corps and Vital Sensitive Communication Hub is located very close to the road, keeping in mind the security needs of the organization the road should be closed. Since no consensus was built up, the Board resolved to put the matter to vote through secret ballot. The slips were distributed to all 15 present Members, out of which 08 slips in favour of closure of Mall Road in front of HQ 2 Corps with the mark “Y” for yes, 06 slips against closure of Mall Road in front of HQ 2 Corps with the mark “N” for No and 01 slip with the mark “A” for abstain were tendered. Hence the decision for the closure of Mall Road in front of HQ 2 Corps is passed accordingly. The Board also resolved that the Mall Road be made accessible by the Army authorities/LMA for concerns related to fire, safety, health, policing etc. in emergency conditions and natural calamities.
